**The Special Lok Adalat will be held from 10.00 am onwards, on 15<sup>th</sup> March, 2008, SATURDAY, at Delhi High Court Legal Services Committee, Shaheed Bhagat Singh Place, Near Gole Market, New Delhi - 110001. Consumers may come in person or through their Advocates.**
