

**Application/Declaration under Amnesty Scheme to replace tampered / suspected
tampered meter
Amnesty scheme 2008**

affirm and say as follows:

1. That I/We am/are registered consumer/user of electricity connection bearing No. _____ installed in property No. _____.
2. That I hereby apply for grant of amnesty under the 'Voluntary Declaration of Tampered Meters' scheme launched by BRPL with approval of DERC in respect of the aforesaid connection.
3. That I have read and understood the aforesaid scheme and hereby undertake to abide by the terms and conditions of the same. I state that the present application is strictly in accordance with the aforesaid scheme and all terms and conditions of the same will be binding upon me.
4. I/We hereby declare the following information:

5. I/We am/are using the load of _____KW/HP instead of sanctioned load of _____KW/HP for _____ (purpose) as against the sanctioned purpose of _____.
6. My/ our meter is tampered and therefore I am applying for amnesty under the "Voluntary Declaration of Tampered Meters" scheme launched by BRPL.
7. I/We undertake to pay all charges which are payable by me under the aforesaid scheme including, but not limited to, the Cost of Meter, penalty charges and other applicable charges under the scheme. The grant of amnesty under the scheme shall be available to meet only on full and final payment of the charges as intimated by BRPL by its Demand Note.
8. I undertake to make payment of the dues demanded by BRPL under the Amnesty scheme. In case any installments for making payment are granted by BRPL on my request I undertake to make payment of all the installments within the stipulated period. Any non payment/ default in payment of installments/ bills in time will entitle BRPL to withdraw the benefit granted to me under this scheme and shall also attract disconnection of supply in accordance with the applicable rules/ regulations/ clauses/ laws etc.
9. In case I fail to make payment against the generated Demand Note till the last date of scheme, I shall not be entitled to any benefit under the scheme and my application shall be liable for rejection at the sole discretion of BRPL. BRPL shall have the right to take the further action as it deems fit in accordance with the applicable rules/ regulations/ clauses/ laws etc.
10. I hereby certify that my premises/connection No. _____ mentioned above has not been checked inspected by any BRPL official and found/declared tampered. I also certify that no proceedings, including any court case or Enforcement case is pending against the declared K.No. In case it is subsequently found that any such case was pending with respect to the electricity connection, all benefits granted to me under this scheme shall stand withdrawn and I shall be liable for consequences, civil and criminal, arising out of such case.

11. I am fully aware that any unsettled enforcement case shall not be eligible for the "Amnesty Scheme" and shall attract the normal treatment as per applicable rules/ regulations/ clauses/ laws etc. Also in case of false declaration by me, I shall not be entitled to avail the benefits of the "Amnesty Scheme" and any amount paid by me under this scheme shall not be refunded and be adjusted against the normal Enforcement Bills. I shall also be liable for being proceeded with under the relevant provisions of law in such case.
12. Availing of this scheme shall not absolve me from paying any outstanding arrears and/ or disputed amount of the past period (along with LPSC till date). BRPL reserves the right to disconnect the electricity supply at any point of time in the instance of me not making payment against any outstanding dues, as per applicable rules/ regulations/ clauses/ laws etc.
13. I also undertake and agree that the relaxation proposed in the "Amnesty scheme" is on the mutual understanding between me and BRPL to the effect that I would not resort to any means of dishonest abstraction of energy in future including tampering/ theft/ unauthorized used etc. If any such case is detected, it shall be strictly dealt with by BRPL without any exception or relaxation. I shall also be liable for civil and criminal action as per law.
14. I solemnly declare that the contents of my aforesaid application are true and correct to my knowledge and all information provided therein is correct. In case any of the above information is found to be false, the benefit of the Amnesty scheme and all concessions granted to meet thereunder shall be liable to be withdrawn at the sole discretion of BRPL and it shall be entitled to take such civil and criminal action against me as it may deem fit and proper and shall also be entitled to disconnect the supply of electricity to my aforesaid connection/premises.
15. I hereby also request that the sanctioned load be enhanced from existing _____ kW to _____ kW. I undertake to pay the applicable charges to effect the requested Load Enhancement. I also agree that BRPL shall be entitled to place me in the correct category of connections /tariff and charge as per the applicable tariff in accordance with law.
