

**Application for Settlement of tariff violation cases**  
**under Amnesty Scheme 2008**

3. That on inspection of my premises by the BRPL on \_\_\_\_\_ a case of Unauthorized Use of Electricity (U.U.E.) under section 126 of The Electricity Act 2003, (as amended by Electricity Amendment Act, 2007) has been booked against me/us.

5. That I/We am/are ready and willing to settle the matter under Amnesty Scheme 2008 and upon settlement undertake to withdraw all cases pending against the Company i.e. BRPL pending in any competent Court of law.
6. That I/We further undertake that upon settlement, I/We will make the entire payment of dues as per the terms of settlement. In case of default in payment of settled amount the entire amount of the U.U.E. bill will be payable, and BRPL will be fully authorized to withdraw the benefit so granted, and take action for disconnection of supply of electricity to my premises as per applicable rules / regulations / law etc.

7. That I/We also undertake that if any outstanding dues, including LPSC are recoverable after the settlement, the same would be cleared by the due date and on failure to do so, BRPL will have the right/authority to immediately disconnect the supply of electricity.
  
8. That I/We undertake to get the category changed immediately by completing the required commercial formalities at the Division Office after depositing the requisite charges. I/We undertake to remove the U.U.E. on completion of commercial requirements for actual use and change of category accordingly within a fortnight. In case the same is detected again at a later stage by the officials of BRPL, I will be liable to pay the charges for U.U.E. from the date of first inspection or any other such date as may be determined by BRPL as per law.
  
9. I/we further undertake to enhance the existing sanctioned load to the actual load being used by me/us by approaching the Division office and completing the commercial formalities including the payment of additional consumption deposit.
  
10. That I/We have read and fully understood the contents of the application and undertake to abide by all the terms and conditions of the same.
  
11. That the information furnished is true and correct to the best of my/our knowledge and nothing material has been concealed there from.
  
12. That I/We undertake to fully indemnify BRPL of any implications arising out of the above said averments.
