The following Clause has been amended:

**Initial Clause:**

### **G. Bid Validity Period:**

The offer shall remain valid till 60 days from e-RA or till the time of signing of LOA (whichever is earlier) and the Bidders shall have no right to withdraw the offer or alter any terms and conditions during the period of validity. In case the bidder withdraws or alters any terms and conditions during the period of validity, EMD submitted by the bidder may be forfeited.

**Amended Clause:**

### **G. Bid Validity Period:**

The offer shall remain valid till 30 days from e-RA or till the time of signing of LOA (whichever is earlier) and the Bidders shall have no right to withdraw the offer or alter any terms and conditions during the period of validity. In case the bidder withdraws or alters any terms and conditions during the period of validity, EMD submitted by the bidder may be forfeited

### **N. Bid submission and evaluation:**

#### **Initial Clause**

15. In case BRPL fails to issue the LoA within bid validity period upto 31<sup>st</sup> March 2022( or extension thereof) from the close of e-Reverse Auction the Successful Bidder(s) shall have the option to exit without forfeiting the EMD.. In case the Selected Bidder(s) is allocated a quantity of power less than the minimum threshold quantum mentioned by it, it shall have the option to exit without forfeiting the EMD

#### **Amended Bill**

15. In case BRPL fails to issue the LoA within bid validity period upto 30 days ( or extension thereof) from the close of e-Reverse Auction the Successful Bidder(s) shall have the option to exit without forfeiting the EMD.. In case the Selected Bidder(s) is allocated a quantity of power less than the minimum threshold quantum mentioned by it, it shall have the option to exit without forfeiting the EMD.

### **K. Payment of Liquidated Damages for failure to supply the Instructed Capacity**

As specified in liquidated damages clause downward revision /cancellation of schedule shall be subject to confirmation from both seller and buyer as per tender terms and conditions

All other terms and condition of BRPL Purchase Tender no.(PMG)/BRPL/E Tender/2022-23/1375 dated 30.06.2022 will remain same.
