SECTION I INSTRUCTIONS TO BIDDERS

- 1.1 BSES Rajdhani Power Limited (hereinafter referred to as "BRPL") is engaged in the business of Distribution of Electricity in 2 circles (West & South) covering 22 nos. divisions.

 - b) Revalidation of existing manpower providing agencies
- 1.3 The bidder must qualify the requirements as specified in SECTION-II. The interested bidders are required to submit documents in support of the qualifying requirement.

- 1.7 BSES Rajdhani Power Limited reserves the right to accept or reject any Bid and to annul the Bidding process and reject all Bids at anytime prior to finalization of enlistment, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for the Company's action.
- 1.8 After bid evaluation, the list of qualified bidders will be posted on BSES website.
- 1.9 BRPL reserves the right to assess the capability and capacity of the company/firm independently in addition to the details/information furnished by the applicant. BRPL also reserves the right to accept/modify/relax any of the conditions while evaluation/assessment without assigning any reason thereof and to seek additional information, if required.
- 1.10 The Enlistment of new Agencies and Revalidation of existing Agencies shall remain valid for a period of 2 (Two) years from the date of expiry of previous registration/revalidation. BRPL shall only entitle him to be considered for issue of tender papers subject to the conditions laid



down in each individual Notice Inviting Tenders. It shall not confer any right on him either to be necessarily issued the tender papers or for award of work.

- 1.11 Short listing and grading of vendors would be carried out depending on various criteria including Technical competence, financial capability, workmanship including quality of work carried out in the past, resource capability, adherence to statutory requirements etc.
- 1.12 Incomplete applications and applications not accompanied with supporting documents are liable to be rejected.
- 1.13 BRPL reserves the right to ask for additional information/supporting documents as and when required.

SECTION – II ELIGIBILITY & EVALUATION CRITERIA

(A) Qualification Criteria:-

The prospective bidder must qualify all of the following requirements to be eligible to participate in the bidding. Bidders who meet following requirements will be considered as successful bidder and management has a right to disqualify those bidders who do not meet these requirements.

(A.1) Technical Qualification Criteria:

- (A.1.1) The bidder should have at least 3 years experience in providing manpower resources to Public Sector Companies/ Government Departments, utilities, registered companies etc. The bidder must be capable of handling unskilled, skilled, semi skilled, graduate manpower etc.
- (A.1.2) Headcount of at least 700 employees, on payroll, of which at least 175 personnel should have been deployed against a single contract for a period of at least one year.

The bidder shall give declaration on its letter head regarding 700 employees on its pay roll along with PF Challans for the month of Sep'21 & Oct'21 as documentary proof.

- (A.1.3) The Bidder should have P.F. / ESI Registration (Certificate to be enclosed) according to the Acts of Government / Labour Laws. A minimum of 300 Employees should be covered under P.F. /ESI (Proof should be enclosed).
- (A.1.4) The bidder should be registered under Shops & Establishment Act for local office in Delhi NCR (Labour Dept.)The bidder to enclose certificate in this regard.
- (A.1.5) Bidder should have an office in Delhi NCR. Bidder to submit details of such office on their letter head. The Head/ Incharge of this office should be competent enough to take all decisions related to the contract.
- (A.1.6) For Existing vendors/ registered vendors of BRPL, evaluation will also include the contract performance in terms of HR issues, all statutory Compliance parameters and timely wages disbursement by Vendors. BRPL reserves the right to disqualify their bid based on the above performance parameters in spite of them meeting the above qualification criteria.
- (A.1.7) Bidder should be Registered Entity in India on or earlier than 1st April 2015, i.e The bidder should be an Indian Registered Company under Companies Act 1956 / Proprietorship Company/Partnership Company. Copy of Certificate of Incorporation/Registration/Partnership Deed or any other relevant document, as applicable, should be submitted along with a copy of address proof.

(A.2) Commercial Qualification Criteria:

(A.2.1) Bidder must provide proof of having Cumulative Turnover of Rs. 45 Cr. for last three consecutive financial year (FY 18-19, 19-20, 20-21) subject to annual turnover in any of the last



three completed consecutive financial years i.e. FY 18-19, 19-20, 20-21 should not be less than Rs. 15 Cr. In case the audited balance sheet is not available with the bidder for 20-21, the bidder shall submit the audited balance sheet for FY 17-18 or turnover certified by the auditor of the firm for FY 20-21.

- (A.2.2) Bidder must provide proof of having solvency of an amount equal to Rs. 1 Crores from any nationalized/scheduled commercial bank.
- (A.2.3) Bidder should have PAN No & GSTIN and necessary proof should be enclosed.
- (A.2.4) Entities that have been debarred/blacklisted by any Private/central/state government institution including electricity boards in India will not be considered; in this regard a written statement has to be provided on bidder's letterhead along with other documents. Vendors/ Agencies who have been debarred/ blacklisted/ suspended by BRPL in last 3 financial years will not be considered in this tender.
- (A.2.5) The bidder should submit an undertaking certified by their auditor for "No Litigation" / no legal case is pending with BRPL or its Group Companies. Bidders having any litigation/ legal case pending with BRPL shall not be considered qualified for this tender.
- (A.2.6) The bidder should give an undertaking on their letterhead that all the documents/certificates/information submitted by them against the tender are genuine/true/correct and the copies of documents have been made from the original document/s. Further in case any of the documents/certificates/information submitted by the bidder is found to be false or forged, BRPL at its sole discretion shall be free to take all actions as permitted under law, including forfeiture of EMD and disqualification from participation in the future tenders for 1 year in BRPL & its group companies.

Please note that by participation in tender and submission of bid, the bidder authorize BRPL to verify the bidder's credentials like work order copies, performance certificates etc. submitted by the bidder from the respective issuing client. If required, BRPL may also direct the bidder to provide the required contact details of the client who can confirm the authenticity of the documents submitted to facilitate the verification process within the timelines provided by BRPL. That upon demand the bidder shall be providing such details to BRPL within timelines provided by BRPL. Further in case any of the documents/certificates/information submitted by the bidder is found to be false or forged or the default from the side of bidder in providing the details for verification, BRPL at its sole Discretion shall be free to take all actions as permitted under law, including forfeiture of EMD disqualification from participation in the future tenders for 1 year in BRPL & its group companies.

The bidder shall submit all necessary documentary evidence to establish that the bidder meets the above qualifying requirements.

Please Note:

i) Firms who are debarred/ blacklisted in other utilities /BSES in India will not be considered.



- ii) Company reserves the right to carry out technical capability/ infrastructure assessment of the bidders by facility/office inspection or by any other means and company's decision shall be final in this regard.
- iii) No joint ventures/ consortiums are allowed.

Also, the Bidder shall furnish the following technical & financial documents along with the tender:
