Sub: Fuel and Power Purchase Adjustment Surcharge (FPPAS) for July 2026.

Dear Sir,

1. We write in reference to the Order dated 10.08.2026 passed by the Hon'ble Commission in the matter of *'Relaxation under Regulation 172 of the Delhi Electricity Regulatory Commission (Terms and Conditions for Determination of Tariff) Regulations, 2017 and its amendments thereof'* ("**Relaxation Order dated 10.08.2026**").
2. By way of the aforesaid order, the ceiling on Fuel and Power Purchase Adjustment Surcharge ("**FPPAS**") for June 2026 was relaxed from 10% to 17.43%. Thus, an additional FPPAS of 7.43% was allowed to be recovered for the month of June 2026. A copy of the Relaxation Order dated 10.08.2026 is enclosed as **Annexure-1**.
3. The Hon'ble Commission allowed recovery of additional FPPAS of 7.43% for a period of one month. As per Para 1(b) of the Relaxation Order dated 10.08.2026, the relaxation came into effect from the date of issuance of the order i.e., from 10.08.2026. Accordingly, from 10.08.2026 onwards, BSES Yamuna Power Ltd. ("**BYPL**"), in addition to the 10% FPPAS, also levied an additional FPPAS of 7.43% on its consumers.

4. The additional 7.43% FPPAS was levied only from 10.08.2026. Accordingly, BYPL shall levy the said additional FPPAS of 7.43% till 09.09.2026, i.e., for a period of 1 month from 10.08.2026.
5. In view of the above, with effect from 01.09.2026, BYPL is levying: -
 - (a) **FPPAS @ 10% towards July 2026 from 01.09.2026 till 30.09.2026** in terms of Regulation 134 of the Amended Tariff Regulations, 2026, which specifies mechanism for recovery of FPPAS [*Regulation 134 (as amended by Amended Tariff Regulations, 2026)* is enclosed as **Annexure-2** and Computation enclosed as **Annexure-3**]; along with
 - (b) **An additional FPPAS @ 7.43% from 01.09.2026 till 09.09.2026** in terms of the Relaxation Order dated 10.08.2026.
6. We would also request the Hon'ble Commission to consider BYPL's request for relaxation of FPPAS for July 2026, in terms of its letter dated 17.08.2026.
7. The above is submitted for the kind information of the Hon'ble Commission and without prejudice to the rights and remedies available to BYPL under law.
