### 6. The reasons for not spending the total amount on CSR activities :

- (i) CSR Team formed on 16<sup>th</sup> July 2014. First CSR Committee meeting held on 25<sup>th</sup> September 2014 for approval of CSR Policy, led to reduced time for implementing activities during FY 15 in which Delhi witnessed general and state elections.
- (ii) Based on CSR Committee suggestion, contribution towards One Stop Centres in Govt. Hospitals, Department of Health (DoH) was intimated. BYPL was advised to await final instructions from DoH. Guidelines for contribution towards One Stop Centres issued on 16<sup>th</sup> April 2015.
- (iii) Delay due to clarity on Interpretation of provisions of Companies Act, 2013 on calculation of Net Profit, leading to harmonization of provision of Rule 2f of CSR Rules 2014 read with Section 135 of Companies Act, 2013.
- (iv) Identifying CSR activities, finding suitable partner NGOs/ agencies and implementing these activities on the ground is a time taking process. It has a long gestation period.
